#### Voting process - People's Choice

The rules of the Great Australian Fish & Chip Awards for the People's Choice is a public vote of one vote, per person, per state/territory, per calendar day (AEST). All votes must come from a valid email address linked to the person voting. SIA reserves the right to review any and all votes for irregularities and will remove any votes that do not comply with the rules, or which have been submitted from an invalid or fraudulent email address. Vote data is kept for record keeping purposes.

Voting is permitted via <u>www.fishandchipawards.com.au</u> only. All votes must be linked to a valid email address. The People's Choice Award is chosen by the public who can nominate and vote for their favourite store at <u>www.fishandchipawards.com.au</u>. A winner will be named for each Australian State/Territory (Australian Capital Territory, New South Wales, Northern Territory, Queensland, South Australia, Tasmania, Victoria and Western Australia) based on the store which receives the most valid votes during the voting period. The state and territory winners will be announced at the virtual winner announcement event on Tuesday, December 14, 2021 at 10.30am AEDT.
